General:

- This award will be offered to a physical therapy student, physical therapist, or researcher with a special interest in cardiorespiratory physiotherapy in order to present a poster and/or other presentation at CPA Congress on a relevant topic on behalf of the CRD.
- One award of \$800 will be available per year.
- Includes a complimentary 3-year membership to the CRD.
- Unsuccessful applicants will receive a complimentary 1-year membership to the CRD.

Eligibility:

- Applicant must be a CRD member in good standing.
- Have a special interest in cardiorespiratory PT and/or be working or conducting research in this area.

Requirements:

- Must be able and willing to present a poster and/or other presentation at CPA Congress on a relevant topic on behalf of the CRD in the same year as the award.
- Provide a summary of the work to the Gas Exchange (CRD newsletter).

- Submit a rough draft or completed copy of the topic and/or research to be presented at CPA Congress:
 - Arial, 12-point font
 - 1-inch margins
 - Maximum of 1-page in length
